

MODIFICATION NO. 1
TO OHIO COMMUNITY SCHOOL CONTRACT
BY and BETWEEN
Mid-Ohio Educational Service Center ("Sponsor" or "MOESC")
AND
Tomorrow Center ("Governing Authority" or "School")

WHEREAS, the MOESC and the Governing Authority entered into the 2019 Community School Sponsorship Contract ("Contract"); and

WHEREAS, the MOESC and the Governing Authority agree to the following modifications;

NOW THEREFORE, the parties modify the Contract as follows:

1. **Article II.** Insert the following as a new sentence at the end of the Article: "All members of the Board of Directors shall undergo a criminal records check pursuant to Revised Code Section 3319.39, the results of which shall be reviewed by and deemed satisfactory to the SPONSOR."

The rest of Article II remains as originally written in the Contract.

2. **Article III.**

- a. Eliminate the duplicate Section A, and replace with Section B. Re-name the existing Section B as Section C.
- b. In the new Section B (previously duplicate Section A), insert as the first sentence of the Section: "The SPONSOR shall conduct a high stakes review at least once every five (5) years or prior to any renewal decision."
- c. The rest of Article III remains as originally written in the Contract.

3. **Article IV, Section D.** In part 2, division (i), remove "orientation activities that introduce enrolled students to the technology of internet-based instruction" and replace with "intentionally left blank."

The rest of Section D remains as originally written in the Contract.

4. **Article IV, Sections F.**

- a. In Section F, remove "3313.603(J)(1) and (2)" and replace with "3313.603(J)(1) to (3)."
- b. In Section F, insert "3313.6024 [prevention programs]" and "3313.818 [breakfast program]" in correct numerical order.
- c. Remove "3319.074" from Section F.

d. The rest of Section F remains as originally written in the Contract.

5. **Article IV, Section I.** In the second sentence, insert “and all members of the Board of Directors” after the words “all staff.”

The rest of Section I remains as originally written in the Contract.

6. **Article IV, Section K.** In the first sentence of part 2, replace “Sections 3313.611 [adult education diploma], and 3313.614” with “Sections 3313.611 [adult education diploma], 3313.614 [alternative conditions for award of diploma], 3313.6114 [diploma seals], and 3313.618 [graduation requirements].”

The rest of Section K remains as originally written in the Contract.

7. **Article IV, Section M.** In part 5, insert as the final sentence of the Section: “The names of the members of the Board of Directors shall be posted on website.”

The rest of Section M remains as originally written in the Contract.

8. **Article V, Section A.** In part 2, insert as a new sentence: “The SPONSOR’s analysis shall be based on the Education Plan in Exhibit 1 Part A and the Performance and Accountability Standards in Exhibit 3, state issued report cards, and any other analysis conducted by the Ohio Department of Education.”

The rest of Section A remains as originally written in the Contract.

9. **Article VI.** In the first sentence of the second paragraph, insert “which shall include a high-stakes review to be conducted at least once every five (5) years and prior to any renewal” after “following.”

The rest of Article VI remains as originally written in the Contract.

10. **Article VII.** Create a new Section L, which shall state: “The School shall notify the SPONSOR of any impending merger at least sixty (60) days prior to the effective date of the merger. In the event of a merger, this Contract shall not be assigned to the sponsor of any surviving entity.”

The rest of Article VII remains as originally written in the Contract.

11. **Exhibit 3** shall be replace in its entirety with the attached.
