General Update

Hello Everyone,

As a sponsor of the Tomorrow Center, one of the requirements is to collect data from stakeholder groups over the course of a school year. One of the stakeholder groups I recently collected data from was the students at the Tomorrow Center. They were asked to complete a Microsoft survey, with a total of 88 responses completed. This represented approximately 79% of the 112 students enrolled at the Tomorrow Center. The sponsor wanted to obtain information on how students felt about the school. The results of the survey will be shared with the Tomorrow Center's Director of School, and in turn, she will share these results with her staff.

Below is a summary of the survey results, rounded to the nearest whole number.

1. I like my school.

- **a.** 41 or 47% of the students strongly agree
- **b.** 38 or 43% of the students agree
- **c.** 5 or 6% of the students neither agree nor disagree
- **d.** 0 or 0% of the students strongly disagree
- e. 2 or 2% of the students disagree
- **f.** 0 or 0% of the students replied "not applicable"
- **g.** 2 or 2% of the students replied "other"

2. I feel successful at my school.

- **a.** 27 or 31% of the students strongly agree
- **b.** 48 or 55% of the students agree
- c. 9 or 10% of the students neither agree nor disagree
- **d.** 1 or 1% of the students strongly disagree
- **e.** 0 or 0% of the students disagree
- **f.** 0 or 0% of the students replied "not applicable"
- **g.** 3 or 3% of the students replied "other"

3. At my school, I develop good work habits such as being responsible, on time, and disciplined.

11. My school assists me in establishing both personal and career goals.

- **a.** 37 or 42% of the students strongly agree
- **b.** 39 or 44% of the students agree
- c. 8 or 9% of the students neither agree nor disagree
- **d.** 1 or 1% of the students strongly disagree
- **e.** 1 or 1% of the students disagree
- **f.** 1 or 1% of the students replied "not applicable"
- **g.** 1 or 1% of the students replied "other"

12. I would recommend my school to others?

- **a.** 81 or 92% of the students replied "yes"
- **b.** 5 or 6% of the students replied "no"
- **c.** 2 or 2% of the students replied "other"

Policy Update

There really are no legislative updates of importance at the moment. While we know that schools are "closed" through the balance of the current school year, we do not know, yet, about

next year. Summer school raises an interesting question as technically Ohio's school year runs from July 1 to June 30, with schools being required to have a certain number of hours of instruction during that time. When the Governor said that schools were closed for the balance of this school year, did he mean the end of the traditional year (late May/early June in most cases) or through the legal end of the year (June 30)? Although, the Governor has said that Ohio will begin to reopen after the stay-at-home order expires on May 1, he has delayed providing details of how Ohio will reopen - what the new rules might be. The latest announcement has been that details will be provided during the Monday, April 27 press conference.
