## 2020-21 Notes:

Revenue and expense estimates will not be finalized until September so this financial report only reflects actual activity for the month. Revenue was impacted by the following:

- (-) MVNU did not renew their lease
- (-) minimal activity in the Conference Center
- (+) fiscal fee collected for Fy'20 from ABRAXAS/FIRST programs
- (-) fingerprinting is by appt only, no walk-ins
- (-) most PD events cancelled or re-scheduled
- (+) print shop engraver was sold for \$10,000

Expenditures were routine for the month, with most variations between last year and this year attributed to timing. \$23,097 was the amount transferred to cover the Print Shop deficit, as compared to \$27,459 the year before.
