## General Update

Hello Everyone,
As a sponsor of GOAL Digital Academy, one of the requirements is to collect data from stakeholder groups over the course of a school year. One of the stakeholder groups I recently collected data from was the students at GOAL Digital Academy. They were asked to complete a Microsoft survey, with a total of 588 responses completed. This represented approximately $72 \%$ of the 813 students enrolled at GOAL Digital Academy. The sponsor wanted to obtain information on how students felt about the school. The results of the survey will be shared with GOAL Digital Academy's superintendent, and in turn, she will share the results with her faculty.

Below is a summary of the survey results, which are rounded to the nearest whole number. The actual graphs as well as comments made by the students are attached to this newsletter.

## I like my school.

a. 219 or $37 \%$ of the students strongly agree.

## Policy Update

While the General Assembly has been largely focused on crafting the FY 2022-2023 biennial budget and the transportation budget, several proposals related to primary and secondary education have also been introduced for consideration. Recently introduced legislative proposals include:

SB-140, offered by Senator Schaffer and including Senator Romanchuk (serving the Mansfield area) as a co-sponsor, seeks to modify the property tax exemption procedures for community schools. Under current law, a community school can request an exemption from property tax for properties that would otherwise be subject to a property tax. If the exemption is granted, it continues from year to year whether or not the community school reapplies for the exemption. SB-140 seeks to remove this provision. SB-140 was introduced on March 23, 2021, and assigned on March 24 to the Ways and Means Committee for initial consideration.

Representative Boggs and Lightbody are the primary sponsors of HB-147, which seeks to require ODE to inform parents and students to request an investigation into a district's compliance with its own policies relating to harassment, intimidation or bullying. The procedures established by ODE must include an opportunity for the parent/student to have a hearing. Should ODE find that the school's policies were not followed, the agency would order the school to comply in a manner and time frame specified by ODE. HB-147 was introduced in late February and assigned to the Primary and Secondary Education Committee. As of this writing, no hearings have been held.

HB 170, sponsored by Representatives Bird and Richardson, and a companion piece, SB-111, sponsored by Senators Blessing and Brenner, seek to address how various COVID relief funds might be appropriated for primary and secondary education purposes. Although HB-170 was favorably reported by the House Primary and Secondary Education Committee on March 17, 2021, it was re-referred on March 23 to the Finance Committee for further consideration. SB111, on the other hand, was approved by the Senate on March 24, 2021, and sent to the House for consideration by that chamber. It was introduced into the House on March 25 but as of this writing not assigned to a committee.

HB-200, sponsored by Representatives Jones and Robinson, seeks a major overhaul of the state's school report card. Among the changes being sought in the proposed legislation are:

1. The elimination of letter grades and replacing them with ratings of: significantly exceeds expectations, exceeds expectations, meets expectations, making substantial progress towards expectations, in need of support.
2. Proposes five performance measures: achievement, closing the gap, progress, 3rd Grade Reading Guarantee, and graduation. ODE would establish the criteria for meeting each performance indicator.
3. While performance ratings would be assigned for each individual performance measure, an overall performance rating would be prohibited.
4. Additional data reported, but not rated, would include information on 4- and 5-year graduation cohorts, performance on K-3 diagnostic assessments and compliance with PBIS.

HB-200 was introduced in early March 2021 and is currently before the House Primary and Secondary Education Committee for initial consideration. Sponsor testimony was provided during the March 16 hearing.
