OCCUPATIONAL and PHYSICAL THERAPY SERVICES AGREEMENT

This agreement, made and entered into at Mount Vernon, Ohio, this 5th day of January, 2022, by and between Mohican Rehabilitation Services, LLC ("MRS") 112 Harcourt Rd., Suite 1, Mount Vernon, Ohio 43050, and Mid-Ohio Educational Service Center ("MOESC") 890 West Fourth Street Mansfield, OH 44906

WHEREAS, Mohican Rehabilitation Services, LLC operates an Occupational Therapy (OT) Department providing services to patients by licensed Occupational Therapists and Occupational Therapist Assistants; and operates a Physical Therapy (PT) Department providing services to patients by licensed Physical Therapists and Physical Therapist Assistants;

AND WHEREAS, Mid-Ohio Educational Service Center desire the professional services of Occupational and Physical Therapy;

NOW THEREFORE, in consideration of the mutual promises contained herein, MRS and Mid-Ohio Educational Service Center hereby agree as follows:

1. Mid-Ohio Educational Service Center hereby engages MRS to provide professional Occupational and Physical Therapy services to its students/patients.
2. During the term of this agreement, Mid-Ohio Educational Service Center will make available reasonable physical facilities for the provision of services, or services will be provided in home.
3. MRS agrees that OT and PT services will be provided in a professional manner in accordance with the laws governing the practice of OT and PT in the State of Ohio.
4. MRS shall provide OT and PT evaluations of and services to students of Mid-Ohio Educational Service Center.
5. MRS shall conform to all applicable Mid-Ohio Educational Service Center' policies concerning documentation.
6. MRS shall prepare documentation that includes the care given, instruction and assessments made. Such documentation shall be incorporated in to the student's record within five (5) days after rendering the service.
7. MRS's compensation for said services shall be \$75.00 per hour for occupational and physical therapy services. MRS reserves the right of first refusal on all cases. Billable time to Mid-Ohio Educational Service Center

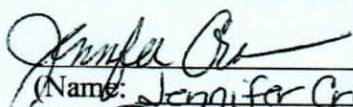
8. includes direct treatments, documentation, meetings regarding patients, and travel from portal to portal, at the rate of **\$0.55 per mile**. Services will be billed on a monthly basis and is payable within fifteen (15) days of Mid-Ohio Educational Service Center receipt of the billing statement.
9. This Agreement becomes effective when mutually signed by both parties. It shall continue in effect for three (3) months from such date.
10. A thirty (30) day termination notice is required of either party and shall be delivered to the respective parties by registered or certified mail.
11. Mid-Ohio Educational Service Center shall not directly or indirectly employ, contract with, or otherwise engage the professional services of the employees or staff of MRS during the duration of this agreement and for twelve (12) consecutive months following termination of this agreement.
