We are pleased to inform you that the GEER II - Governors Emergency Relief Fund has been awarded in the amount of \$120,887.00. This grant is a subaward from the Governor of the State of Ohio's total award of \$46,303,196 that was awarded to the Governor of the State of Ohio on January 8, 2021. The award amount may be adjusted at any time via notification from the Ohio Department of Education (Department) at the request of the Governor of the State of Ohio.

The award period for this grant is 03/13/2020 - 09/30/2023 and obligations made prior to the start of the award period are unallowable. <u>All funds must be obligated, liquidated and a Financial Expenditure Report (FER) submitted by</u> <u>9/30/2023.</u> In addition, the program specific assurances must be signed and uploaded into the Department e-grants system, Comprehensive Continuous Improvement Plan (CCIP). For a copy of the assurances and grant application that will need to be uploaded to the CCIP, click <u>here</u>. This document must be signed and uploaded into the Comprehensive Continuous Improvement Plan (CCIP) before the application grant can be approved.

Grantees should upload the assurances and complete the application before June 30, 2022. If a grantee does not accept the grant, the Department may remove the allocation for reallocation. Project Cash Request (PCR's) and FER's must be submitted electronically through CCIP. Assistance with <u>PCRs</u>, and <u>FERs</u> as well as other helpful information are available on the Department's website and can be found by clicking <u>Grants Administration</u> or emailing the Office of Grants Management at <u>Grants.Management@education.ohio.gov</u>. For those grantees who have not worked in the CCIP, follow the Grants Management <u>Quick Reference Guide</u>. This document will help guide you to get set-up and manage the grant from beginning to end.
