





SLPs can be the SDI and have intervention specialists be the related service for a student that needs academic support but has the disability category of SLI.

We discussed how to handle issues with section 7 and the category SLI and if academic goals can be used if category is SLI

That academic goals can be added to speech IEPs, but only in rare cases (per Bernadette's email), and SLPs would not be responsible for those goals.
