

CONTRACT ADDENDUM

THIS CONTRACT ADDENDUM dated this 11th day of May, 2022

BETWEEN:

The Governing Board of The Mid-Ohio Educational Service Center ("Mid-Ohio ESC")

-AND-

The SPARC Council ("SPARC")

Background

- A. Mid-Ohio ESC and SPARC (the "Parties") entered into the contract (the "Contract") dated July 1, 2021 for the purpose of Fiscal, Administrative and Educational services.
- B. The Parties desire to amend the Contract on the terms and conditions set forth in this Contract Addendum (the "Agreement").
- C. This Agreement is the second amendment to the Contract.
- D. References in this Agreement to the Contract are to the Contract as previously amended or varied.

IN CONSIDERATION OF the Parties Agreeing to amend their obligations in the existing Contract, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to keep, perform, and fulfill the promises, conditions and agreements below:

Amendments

1. The Contract is amended as follows:
 - a. Mid-Ohio ESC will provide grant administration for competitive grant projects that have been awarded to SPARC Council under the following conditions:
 - i. The Superintendent will determine which SPARC grant projects Mid-Ohio ESC will administer on a case by case basis.
 - ii. The Superintendent will notify SPARC Council in writing within 30 days of the notice of grant award of the Superintendent's decision to administer the grant
 - iii. Mid-Ohio ESC may decline to administer any grant projects at the discretion of the Superintendent.
 - b. As the fiscal agent, Mid-Ohio ESC has the first right of refusal to administer a grant received by SPARC. If Mid-Ohio first declines to serve as the grant administrator, SPARC Council may seek a third party for grant administration.
 - c. To administer competitive grant projects approved by the Superintendent, Mid-Ohio ESC will provide grant administrative services including, but not limited to:
 - a. Fiscal agency
 - b. Grant staffing, implementation and oversight for the activities that are outlined in the awarded grant proposal or are appropriate to administering the project.
 - c. Compliance and reporting as required by the awarding entity

- d. Coordination of evaluation activities at all levels as required by the grant awarding entity (e.g. local, state, federal evaluation reporting)
 - e. Ensure disclosures of student-level data are made in accordance with the Family Educational Rights and Privacy Act (FERPA, 34 CFR Part 99)
2. The role of the SPARC Council in the grants administered by Mid-Ohio ESC will be to:
- a. Approve the annual grant budget and Budget Summary Detail Report
 - b. Be knowledgeable about the grant project, goals and activities to advocate for the program among partners, stakeholders and the community
 - c. Participate in grant required activities as defined by Mid-Ohio ESC and the grant awarding entity
 - d. Support sustainability efforts for the grant activities
 - e. Convene SPARC Council members as needed for supporting communication among partners and stakeholders
 - f. Fulfill any other obligations specific to SPARC Council as required by the grant award

No Other Change

01. Except as otherwise expressly provided in this Agreement, all of the terms and conditions of the Contract remain unchanged and in full force and effect.

Miscellaneous Terms

02. Capitalized terms not otherwise defined in this Agreement will have the meanings ascribed to them in the Contract. Headings are inserted for the convenience of the parties only and are not to be considered when interpreting this Agreement. Words in the singular mean and include the plural and vice versa.

Governing Law


03. Subject to the terms of the Contract, it is the intention of the Parties that this Agreement, and all suits and special proceedings under this Agreement, be construed in accordance with and governed, to the exclusion of the law of any other forum, by the laws of the State of Ohio, without regard to the jurisdiction in which any action or special proceedings may be instituted.




