The Grant Application Approval Process

The Grant Application Approval Notice is an important step in the Department's grant award process enabling grantees to access their awarded funds. The grantee receives the Grant Application Approval Notice after the Department reviews and approves the funding application for its completeness and quality. Grant funds are available to be accessed for project cash requests (PCRs) as of the date of this award notice: Monday, 22 August 2022.

Period of Availability

Grant funds may be used for allowable activities back to the substantial approval date established when the grantee submitted the grant application until the end of the period of availability. Obligations requested prior to your substantially approved date are un-allowed. All funds must be obligated by June 30, 2023 and liquidated by September 30, 2023. The Final Expenditure Report (FER) must be received by September 30, 2023. Failure to provide the FER in a timely manner could result in the final payment not being made or a refund due of awarded funds. Project Cash Requests (PCRs) and FERs will be submitted through CCIP.

Special Notice:

Access to and availability of the funds for this grant are subject to all the requirements of the Notice of Award that was provided at the time of the allocation and must be used according to the application submitted by the grantee and approved by the Department. The grantee must comply with all grant assurances and requirements. Grantees failing to comply with any grant assurance or requirement is subject to progressive enforcements including but not limited to, increase risk factor, intensive monitoring, limitation or restrictions to the grant funds, and other financial consequences and reimbursement.
