- Staffing Needs:

- Vision Services Staffing: Still Need TVI (Part-Time)
  - Ohio State Services for Deaf-Blind contract - Kallie Poast, .4 FTE, Contract to be recommended for approval at the August 15th meeting.
  - Meeting with the full team on August 9, 2023, to reconfigure assignments and consider alternative coverage.
  - Meeting with Occupational Therapists to assess interest in training in Convergence Insufficiency therapeutic services.
- Parent Mentors:
  - Still waiting on the grant to be released in CCIP. Grant application has been drafted to sustain two parent mentors for 23-24 school year. Will submit when grants are released. Word from Lyndsay Havey, ODE Parent Mentor Representative, is that the grant will be released “any day now”.
  - Parent Mentor Team met on August 8, 2023, to review district assignments, 23-24 meeting dates, proposed Scope of Work, 23-24 PM Budget, cubicle space, and supply storage.
  - The Parent Mentors will not need the space/desk in the Related Services *wing*. Their supplies will be moved to the Student Services Resource Room next to Megan Shooks office.
