



## MID-OHIO EDUCATIONAL SERVICE CENTER GOVERNING BOARD and PARTICIPATING DISTRICTS

### Mansfield Christian Title I Pooling Contract

In compliance with the purpose of the Title I Non-Public School Program, Mid-Ohio ESC, Mansfield Christian School, and participating Title I Public Schools agree that:

An associating Staffing Agreement (hereinafter referred to as "Agreement") affiliates with this Title I Pooling Contract and is entered into on this **24th day of September** by and between Mansfield Christian School, (hereinafter referred to as "District A") and the Governing Board of the Mid-Ohio Educational Service Center.

The Mid-Ohio ESC will employ, on behalf of Mansfield Christian School, ODE licensed teachers selected by Mansfield Christian administration, to implement the Title I program serving school district students attending non-public schools and as contracted by local school districts. The amount of funding to support the Title I program will be calculated from the Ohio Department of Education's CCIP per pupil amount based on economic eligibility as reported by the non-public schools to LEA. The number of eligible pupils multiplied by the per pupil allocation for each participating non-public school will be used to calculate the total amount due to the Mid-Ohio ESC from the participating school district.

Tutors will use multi-criteria which include a standardized assessment and/or diagnostic assessment and student grades to rank students based on academic performance. Mid-Ohio Educational Service Center and all Partnering School Districts agree to pool funds and service the most at-risk students by rank order regardless of the district of residence. Tutors will provide instruction based on the state academic standards. Non-public schools will administer a standardized post-test and/or End of Year diagnostic test to evaluate student growth and the effectiveness of the Title I non-public tutoring program. The non-public school will provide copies of the student progress reports, multi-criteria forms, rank order lists, teachers' schedules, school parent compacts, and evidence of parent engagement before invoicing for the service amount with the Participating Districts and the Mid-Ohio Educational Service Center. These documents will also be shared with the State and Federal Program Office upon request.

The Mid-Ohio ESC will provide the services listed above as well as those included in the **Mid-Ohio ESC Title I Pooling Staffing Agreement** and corresponding job descriptions.

Each district agrees to remit to Mid-Ohio ESC the full amount of their CCIP Title I allocation toward provision of Title I services provided to identified, targeted students attending Mansfield Christian School. Qualifying expenses are intended to include all employment related services incurred by MOESC for the service including but not limited to salary, retirement, fringe benefits,

unemployment, workers’ compensation and agency fees. District A agrees to pay all qualifying expenses not covered by the sum of all districts CCIP Title 1 Allocations. MOESC shall issue invoices to each District in May of the fiscal year and each invoice shall be paid in full by the District(s) within thirty (30) days of receipt thereof.

Participating districts agree to work with any remaining funds in consultation with the nonpublic schools to expend appropriate funds on other allowable activities including but not limited to summer programming, professional development, parent engagement, and/or socio-emotional supports that are allowable under Title I and to carry over any funds not expended to the following year.
