### **Grants/Entitlement Funding Application Update**

#### SLP/SP Consultant Grant

On Wednesday, November 12<sup>th</sup>, Superintendent Kimmel and both Student Services Directors, Crum and Turlo, attended the scheduled SLP/SP Consultant Grant Scope of Work meeting at the request of Jo Hannah Ward, M.Ed., LPCC-S, Administrator with the Office for Exceptional Children. At that meeting, a follow-up meeting was scheduled. In addition, MOESC is still awaiting Final Approved status within the CCIP Funding Application.

#### Office of Safe and Supportive Schools: Mental Health Service Professional (MHSP) Demonstration Grant

Mid-Ohio ESC submitted the attached application for grant approval under the competitive funding opportunity available to State and local educational agencies. The grant aims to address the shortage of credentialed school-based mental health service providers—specifically, school psychologists—in high-need LEAs, as defined in the Notice of Final Priorities. #### Follow-Up:

Unfortunately, Mid-Ohio was notified by Office of Safe and Supportive Schools, that our application was not accepted for external panel review, because it failed to meet one of the requirements outlined in the NIA. Specifically, the application did not meet one or more of the grant's absolute priorities.
