

Service Contract

This agreement is between McWatters Consulting LLC, 7711 Redman Lane, Reynoldsburg, Oh 43068 and Mid-Ohio Educational Service Center, 890 West 4th Street, Mansfield OH, 44906 for State Fiscal Year July 1, 2026 through June 30, 2027.

McWatters Consulting LLC (Service Provider), agrees to provide for the following program services to Mid-Ohio Educational Service Center for 21st CCLC grant funded programs at Galion High School (Grant# 18689) :

- Service provider will monitor student academic improvement outcomes. Data on individual students (student attendance records, pre and post academic records/assessments and event participation) will be collected by participating program administrators and/or program manager and will be monitored by service provider to assure that student academic progress outcomes are being met. Findings will be reported.
- Service provider will monitor youth development and parent engagement outcomes. Service provider will develop monitoring instruments to assure that youth development and parent involvement outcomes are being measured. Monitoring instruments will be distributed, collected and compiled by participating program administrators and/or program manager. Completed monitoring instruments will be analyzed by service provider.
- Service provider will meet as needed with program and district administrators, program administrators and/or project coordinator to review monitoring efforts and provide resources and recommendations for outcome improvement.
- Service provider will provide reports including but not limited to logic model, assessment calendar and mid-year and year-end report summarizing academic, youth development and parent involvement activities outcomes, findings and key recommendations for continuous program improvement. Unintended outcomes will also be reported.

Program evaluation assumes the following:

- Information on individual students (student attendance records, academic records and event participation reports) will be accessible to service provider for quarterly review. Pre and post comparisons will include only those students for whom pre grant intervention and post grant intervention measures are available.
- All measures identified as indicators of academic, youth development and parent engagement outcomes assume monitoring information will be collected in a timely manner and be available to service provider for review and compilation of data.
- All monitoring information will be transmitted electronically to the evaluator for analysis and reporting in a timely manner and be available to service provider at least one month prior to grant report deadlines.

Mid-Ohio Educational Service Center agrees to pay \$9,999.00 for these services. Payment will be made in two installments of \$4,999.50 with first payment due October 1, 2026 and other installment of \$4,999.50 is due April 15, 2027.

The service provider agrees that they are working as an independent contractor with no employee/employer relationship in existence. The fee for service is the entire obligation for Mid-Ohio Educational Service Center with any additional obligation to meet legal requirements accruing to the service provider.
